

Executive Summary

This work defines reference conditions and a reference simulation environment for the simulation of solar combisystems for domestic hot water (DHW) preparation and space heating (SH) for various European climates and a range of building loads. These will be used for simulation studies within the IEA-SHC Task 32 by all participants who intend to compare their new products or ideas with the current state of the art or with other products and system approaches.

The reference climates represent a moderate Northern European climate (Stockholm), a moderate, Central European climate (Zurich), a Mediterranean coastal climate (Barcelona) and a Mediterranean continental climate (Madrid). The heat loads of the reference buildings are 15, 30, 60 and 100 kWh/m²a for the climatic conditions of Zurich. All four buildings have the same architectural design with 140 m² of floor area, but different insulation thicknesses and/or different ventilation systems. The domestic hot water load is assumed to be 200 liters per day at 45 °C.

The reference simulation environment (RefSol) has been programmed with the simulation software TRNSYS. It includes meteorological data, building description files and other load-files together with the main file that contains the description of the system, the so called "deck". The "deck" also contains the description of a standard solar system, solar store, auxiliary heater, pipes, mixing valves and radiators for space heating and the settings for the control of the system. The RefSol files have been continuously tested and improved and the final version described in this report is V45c. Test results concerning stability under changing simulation timesteps or different convergence tolerances are included in section 7 of this report.

Simulation results are written to ASCII text files. An Excel spreadsheet has been worked out that will load the simulation results with the help of Macros and calculate basic indicators for the performance of solar systems that are described in section 6 of this report. The spreadsheet also allows for a fast checking and detecting of energy balances and calculation errors.

This report may be much more detailed than other IEA-SHC Task 32 reports. The reason for this is that all participants who will perform comparative simulations within this Task will work with the reference conditions and the reference simulation environment and therefore depend on an accurate and precise description of these.

Whenever results from simulations based on the reference simulation environment are published, only the choices (climate, building, etc.) and changes made within the reference simulation environment will have to be reported by the author, together with a reference to this report.

1 Approach and intention of this report

The intention of this work was to define reference conditions and a reference simulation environment for the simulation of solar combisystems for domestic hot water (dhw) preparation and room heating for various European climates and a range of building loads. This system, called "RefSol", will be used for simulation-studies within the IEA-SHC Task 32 by all participants who intend to compare their new products or ideas with the current state of the art or with other products and system-approaches.

The used reference building, as well as other parameters, are based on a further development of the reference conditions of the IEA-SHC Task 26. All relevant information from IEA-SHC Task 26 is included in this report, and no particular knowledge of Task 26 reports is needed.

2 Reference climates

Data from four reference locations have been selected which cover the whole range from the tropics to temperate-cold climates; these data sets were used to perform the calculations and generate the results presented in this handbook. The four locations are:

Stockholm, Sweden: represents a moderate, Northern European climate.

Zurich, Switzerland: represents a moderate, Central European climate.

Barcelona, Spain: represents Mediterranean coastal climates with high humidity and

temperature during summer and a moderate climate in winter. The

typical cooling season is between April and October.

Madrid, Spain: represents a Mediterranean, continental climate with high

temperatures during summer but moderate air humidity. The heating

season is longer than on the coast.

The hourly climatic data profiles correspond to the profiles delivered with the TRNSYS simulation software [TRNSYS 16] in the standard format '.tm2'. These data profiles are based on the commercial database Meteonorm® [Meteotest 2003]. Tables 1 to 2 show the characteristics of the used climatic data sets.

The climate Zurich is the basic climate for the definition of the building energy consumption. Cold water temperatures are calculated as dependent on the time of the year (Eq. 2.1).

Figures 1 to 3 show the annual distributions of monthly averages of ambient air temperatures, relative humidity and global horizontal radiation totals, respectively, for each of the selected sites.




Figure 2.1: Annual distribution of average monthly ambient air temperatures for the four locations used in this task.




Figure 2.2: Annual distribution of average monthly ambient air relative humidity for the four locations used in this task.




Figure 2.3: Annual distribution of average monthly global horizontal radiation totals for the four locations used in this task.

3 Reference building(s)

In this part the reference buildings are defined. The definitions include architectural design and orientation as well as the constructive descriptions of all building elements (walls, floors, windows and roof). Four single family houses with different heating loads are defined. The buildings are named after their heating loads (15, 30, 60 and 100 kWh/m²a) for the reference climatic conditions of Zurich with SFH 15, SFH 30, SFH 60 and SFH 100. All four buildings have the same architectural design, but different insulation thicknesses and/or different ventilation systems (see 3.2). In addition to the four buildings classified by heat loads, there is a fifth building that corresponds to SFH 100, but does not have the external venetian blinds shading implemented in the standard SFH 100, and therefore has an increased cooling demand in summer. This building will be referred to as the SFH 100n (no venetian blinds shading).

3.1 Architectural design




Figure 3.1: Sketch of the single-family house (SFH) used in IEA SHC Task 32.

The reference object is a free-standing, two storey single family building (see Figure 3.1). The effective floor area on one storey, including the areas covered by the internal walls and the access areas, is 70.0 m². The glazed area on the south façades amounts to 25 % of the façade area, 10 % on the east and west façades and 6 % on the north façade. Both storeys are simulated as one common thermal zone.

3.2 Façade structures

3.2.1 Wall construction

The construction of the building envelope (external walls, roof and floor slab between ground floor and basement) is more or less reduced to the base slap (storage layer) and the insulation layer. The various materials, layer thicknesses and energy performance data describing the reference building(s) are listed in Table 3.

Figure 3.1 displays the geometry and dimensions of the office building. The resulting areas and volumes are summarized in Table 3.

The window areas are the same for all four building types (15, 30, 60 and 100 kWh/m²a) and are shown in detail in the Table 4.

3.3 Internal gains

3.3.1 Inhabitants




Figure 3.2: Occupancy profile for each day of the week within the reference building.

In the case of full occupancy 3.3 people are present simultaneously in the reference building. This value is based on a mean value from several building-objects evaluated during an Austrian study published in 2004 [HdZ15/2004]. No distinction is made between weekdays and weekend. Numerical values for the overall occupancy profile are displayed in Figure 3.2.

The heat dissipation to the surroundings is assumed to be 100 Watt per person. This value is in accordance with the ISO 7730 [ISO 7730] standard and is based on the following scenario:

Degree of activity - seated at rest

sensible heat: 60 W/person

convective gains: 40 W/person

radiative gains: 20 W/person

latent heat: 40 W/person

humidity: 0.059 kg/hr person

The average internal gains through inhabitants are about 145 W or 1.04 W per square meter net area of the building. This results in a yearly heat gain of 9.03 kWh/m² by the inhabitants of the building.

3.3.2 Electricity

The total electricity consumption of an average household amounts up to 3043 kWh/year [Feist 1998]. We assumed that 58% of this electric energy (12.6 kWh/m²a or 1.44 W/m² in our case), remain inside the building as thermal energy and are classified as internal electrical gains.




Figure 3.3: Weekly internal electricity gains profile for the reference building.

The rate of heat dissipation from electric equipment depends on its operational status and is thus correlated to the occupancy profile in the building. The assumed electrical heat dissipation is assumed to be dependent on the hour of the day and on the day of the week and is shown in Figure 3.3. This weekly profile is based on outcomes from an Austrian study [HdZ15/2004], were about 60 flats are measured in detail.

3.4 Thermal comfort, PMV, PPD and clothing level

Creating a thermally comfortable environment is one of the most important parameters to be considered when designing buildings. Thermal comfort is defined in the ISO 7730 standard as: "That condition of mind which expresses satisfaction with the thermal environment" [ISO 7730]. A definition most people can agree on, but also a definition which is not easily converted into physical parameters. In this reference simulation environment, the PMV¹ and

_

¹ PMV represents the 'predicted mean vote' (on the thermal sensation scale) of a large population of people exposed to a certain environment. PMV is derived from the physics of heat transfer combined with an empirical fit to sensation. PMV establishes a thermal strain based on steady-state heat transfer between the body and the environment and assigns a comfort vote to that amount of strain.

PPD² are calculated and printed out in a separate printer to be evaluated by those who want to work with these parameters. In addition to this, penalty values are calculated if the room temperatures are outside a limited "comfort" temperature range and this penalty is used in the calculation of performance indicators described in section 6.1 and 6.4. If the penalty is too large, then it is recommended to discard the simulation results (see section 7.1).

The Thermal Comfort Equation (PMV, PPD) derived by P.O. Fanger [ISO 7730] combines the effect of six parameters:

- Metabolism (met)³
- Clothing level (clo) 1
- Air Velocity¹
- Air Temperature⁴
- Mean Radiant Temperature²
- Humidity²

Metabolic rate estimation

The metabolism is the energy released by oxidation processes in the human body and depends on the muscular activity. Normally, all muscle activity is converted to heat in the body, but during hard physical work this ration may drop to 75%. For instance when walking up-hill, part of the energy is stored in potential energy of the body.

Traditionally, metabolism is measured in met (1 met=58 W/m² of body surface). A normal adult has a surface of 1.7 m², and a person in thermal comfort with an activity level of 1 met will thus have a heat loss of approximately 100 W.

When evaluating the metabolic rate, it is important to use an average of the activity the person has performed within the last hour. Met values for various activity levels can be found in EN ISO 7730.

In our case the metabolic rate is fixed for all persons through the year with an average value of

which corresponds to the degree of activity "seated, light work".

Clothing level estimation

Clothing reduces the body's heat loss. Therefore, clothing is classified according to its insulation value. The unit normally used for measuring clothing's insulation is the clo unit. The more technical unit m^2 °C/W is also used frequently (1 clo = 0.155 m^2 °C/W).

The clo value can be calculated by adding the clo value of each individual garment. The insulation value for individual garments can be found in EN ISO 7730. In our case the




Figure 3.4: Seasonal varying clothing level [clo] used within the reference building.

clothing level is fixed for all persons through the year with a seasonal varying value. The value range is from 1.0 "typical business suit" to 0.5 "light summer clothing" (see Figure 3.4).

Air velocity estimation

Air movement in ventilated rooms is a combination of forced flow from the ventilation system and free-convection flows caused by temperature differences in the room. Recording air velocity reveals strongly fluctuating patterns of a stochastic nature.

The feeling of comfort in an air-conditioned office is, among other physical parameters, a combination of air velocity and temperature fields. The most common complaint in relation to indoor climate is draught, defined as an undesirable local cooling of the body caused by air movement.

In our case the air velocity is fixed through the year with a preset-value of Eq. 3.2 $v_{AIR} = 0.1 \ [\text{m/s}]$

3.5 Wing wall shading

Type 34 is used in the upstream component mode 0 for the calculation of a wing wall. The parameters are the following:

Receiver height 4 m
Receiver width 4 m
overhang projection 1.5 m
overhang gap 1 m
overhang left extension 2 m
overhang right extension 2 m

3.6 External venetian blinds shading




Figure 3.5: Month-dependent solar transmission for the used sunshades (grey venetian blinds, 80 mm slats, tilt-angle 45°, calculated with the program Parasol⁵).

Overheating due to the solar gains through the glazed areas is reduced by external shading devices. Their transmission is shown in Figure 3.5.

Control of the external shading is modeled as a function of the incident solar irradiation on the horizontal and depending on the room temperature. This shading is not used in the building **SFH 100n** (no venetian blinds shading)

Control strategy (all points must be fulfilled, off-values for hysteresis in parenthesis):

- Total global irradiation on the horizontal is above 300 (200) W/m²
- Room temperature must be above 23.8 (22.8) °C
- 24 hours average ambient temperature must be above 12 °C

3.7 Ventilation

A natural air change rate of 0.4 is assumed due to leakages in the building envelope during wintertime. In summertime a free driven night ventilation mode is activated if the following conditions are met:

- Time between 21:00 and 8:00
- Daily average temperature is above 12 °C
- Room temperature is above 24 °C
- Ambient temperature is 2 K below the actually room temperature

This free driven tilted window ventilation is simulated with Type 358 based on the method from A. Weber [WEBER 1997] using a simple but CFD validated Bernoulli – approach. The air exchange rate through the window is calculated depending on the temperature difference between room and ambient temperature, the geometry of the window and the window opening tilt angle (see section 10).

Three windows with tilt angles of 10° have been defined. Two windows are $1.04 \text{m} \times 1.04 \text{m}$ (H x W) and one window is $2.00 \text{m} \times 0.94 \text{m}$ (H x W).




Figure 3.6: Temperature and the calculated free ventilation curve over ten days of the year for Zurich SFH 15. Troom: room temperature, Tamb: ambient temperature, airch_win: natural airchange rate as a result of open windows simulation (day and night), airch: natural airchange rate assuming open windows only at night and with a minimum of 0.4 h⁻¹ during day and night (used for simulation). Room temperatures are relatively high because of a large influence of internal loads (passive house) and effect of increased night ventilation is relatively small because of high thermal masses.

Figure 3.6 displays the function of the combination between free and fixed ventilation. The dark blue line shows the used air change rate and the light blue one is calculated free driven air change rate.

3.8 Heating and cooling set points

Heating season

The controls of the heating system were set in a way, that the room temperature is kept around $T_{ROOM} = 20 \pm 0.5$ °C and never drops below 19.5 °C during heating season.

Cooling season




Figure 3.7: Boundary set temperatures for heating and cooling according to the DIN 1946/2.

The necessary cooling set temperature of the reference system is defined according to the upper cooling line of DIN 1946/2 with two straight lines depending on the ambient temperature (see Figure 3.7). However, penalties are given for not cooling to the lower cooling line that is set to 25 °C up to an ambient temperature of 26 °C both, for the reference system without solar assisted cooling and for solar systems that provide cooling (see section 6.4).

4 DHW-load profiles

Domestic hot water load profiles are stored in two data-files calculated with the program form Jordan and Vajen [Jordan 2000, Jordan 2001] which can be downloaded free of charge from the homepage of the Solar Energy Laboratory of the University of Wisconsin, Madison.⁶

The load files are based on a timestep of 6 minutes and a daily hot water consumption of 200lt (06Dhw002.txt). The default profile for this setting was chosen from the download.

The dhw-load in kWh/a is different for different climates, as the cold water temperature is calculated dependent on the climate and the time of the year as described in Eq. 2.1. The set temperature for hot water preparation is 45 °C for all cases.

5 Simulation environment




Figure 5.1: Total system layout - template solar system

For simulation studies, a TRNSYS-deck have been established that includes the reference building(s) and gives users the option of choosing one of the above mentioned climate datasets. The TRNSYS-deck also includes a solar system, a water storage tank and all utilities needed for the simulation of a fully operating solar combisystem. The schematic layout of the system can bee seen in Figure 5.1.

TRNSYS Types and versions used for the simulation of the components are listed in section 9.

5.1 General simulation parameters

Tolerances for integration errors and convergence are both set to 0.003. With tolerances set to 0.001, convergence problems may occur in the auxiliary loop. Therefore, the lower limit of this value has been set to 0.002. The default values are used for the TRNSYS differential

equations solver (DFQ 1), equations solver (EQSOLVER 0)⁷ and solver (SOLVER 0). Values for thermal capacity and density of the fluids used in the simulations are listed in Table 7.

5.2 Collector loop

5.2.1 Collector

For collector simulation, Type 832 from Bengt Perers and Chris Bales is used (Type 832, Version Number 2.06) [Perers 2002]. All reference collectors are calculated in Mode 1, without wind or long-wave dependency and with the sky radiation factor set to zero.

5.2.2 Collector heat exchanger

An external heat-exchanger (Type 5) is used in counter flow mode (mode 2) to separate the brine in the collector loop from the water in the storage tank. The UA value is calculated dependent on the collector field area chosen for the simulation (Eq. 5.1) using an equation from [Heimrath 2004]. The heat exchanger is connected to the collector pipes on the primary side and directly to the store doubleports on the secondary side.

The heat exchanger Type 5 does not calculate heat losses of the heat exchanger. Heat losses between collector and store are accounted for by the pipes between the heat exchanger and the collector.

5.2.3 Collector loop flow rate

The mass flow rate on the primary side of the heat-exchanger (collector-side) is calculated dependent on the collector area and the specific mass flow chosen by the user. The mass flow of the secondary side of the heat exchanger is calculated to give the same capacitance flow rate as the primary side.

5.2.4 Collector pipes

Two pipes (Type 31) have been used to connect the collector to the collector-loop heat-exchanger. Base Properties of these copper pipes are listed in Table 10.

Pipe diameter and insulation are calculated based on the flow rate of the fluid in the pipe such that the velocity of the fluid is about 0.6 m/s (Eq. 5.4). The lower limit of the pipe inside diameter is DN 8. Pipe wall thickness is 1 mm, insulation thickness is defined with a simple function that represents closely [EN12976-2] (see Eq. 5.6).⁸

With a collector field aperture area of 15 m² and a specific flow rate of 15 kg/hm², the collector pipe will be DN12. Calculated results for this pipe are shown in Table 11. Heat losses are calculated towards an ambient temperature of 15 °C.

5.2.5 Control of the collector loop

The collector loop flow is controlled by a Type 2 controller. Flow is turned on when collector temperature is higher than the temperature of the collector control temperature sensor in the store plus the upper dead band Temperature, and turned off again when collector temperature drops below the Temperature of the sensor plus the lower dead band temperature. Dead band temperatures can be set by the user in the TRNEDIT interface.

Independent of the output of this controller, collector operation can be suspended for overheat protection reasons as shown in Table 12.

5.3 Storage tank

Type 340 is used to simulate the storage tank. Exactness for the calculation of temperatures (Parameter 121) is set to 0.001 K, heat exchangers are not used, and precision of the mixing process in the store was set to 1000. Refer to the documentation of Type 340 [Drück 2006]. if you need more information about these parameters.

5.3.1 Height and heat losses of the storage tank

The height of the storage tank is calculated as a function of the store volume chosen by the user. Different functions are applied for large (>14 m³) stores as the height does not increase with the same proportion for seasonal stores as it does for short-time stores. The functions are a simplified version of the ones derived by Heimrath [Heimrath 2004] which are based on data of solar stores sold on the market (Eq. 5.7,Eq. 5.8,Eq. 5.9).

For a store volume of 1000 liter, an insulation thickness of 0.15 m and $Fcorr_{UAstore,B} = 1.4$, the resulting overall UA value of the store is 18.0 kJ/hK.

5.3.2 Auxiliary heated volume and number of nodes

The number of nodes and the volume for auxiliary heated DHW (V_{aux}) are a function of the store volume chosen by the user in the TRNEDIT interface. V_{aux} is 0.2 m³ per default. The number of nodes of the store is calculated such that V_{aux} covers exactly 10 nodes. As the maximum number of nodes is reached, V_{aux} is increased in order to still cover 10 nodes of the store.




Figure 5.3: Number of nodes and volume of auxiliary heated DHW as a function of store volume.

The storage control Type 890 is used for the control signal for auxiliary heating of the DHW section of the store. The control signal is on (DHW preparation) whenever the first auxiliary On/Off sensor temperature drops below $T_{aux,set}$ - 8 [°C], and once it is on it will stay on until the second auxiliary On/Off sensor temperature is above $T_{aux,set}$ - 2 [°C]. Auxiliary heating of the DHW section of the store is possible any time of the day (not restricted through time windows).

The overall heat transfer coefficient of the heat exchanger has been set to a value which results in a return temperature of 15 °C to the store in the case of 10 °C cold water temperature, 60 °C temperature from store and a secondary mass flow rate (DHW) of 1200 kg/h.

5.6.4 Mixing valve

6 Performance indicators

To compare results obtained from the simulation of solar heating and/or cooling systems with the Task 32 reference TRNSYS deck, it is recommended to use fractional energy savings and the FSC method developed in the IEA-SHC Task 26 and described in the Task 26 handbook [Weiss 2003]. The indicators and their calculation are shown in this section. And a new indicator for solar heating and cooling is introduced in section 6.2. Please note that the calculation of penalties for high room temperatures differs from the one proposed in the IEA SHC Task 26.

6.1 fractional savings indicators from IEA SHC Task 26

The *fractional thermal energy savings* $f_{sav,therm}$ are a measure of the percentage the auxiliary (non-solar) energy input for heating can be reduced with the solar system, this term does not account for electricity use unless it is used directly for heating. Unlike in Task 26, no difference is made in Task 32 for the electricity coming from renewable sources and non renewable sources. The efficiency of electricity production and distribution η_{el} is 0.4 in all cases. This value reflects not only the average UCPTE efficiency of conversion and transport, but also the thermodynamic value of the energy and the higher market price of electricity. Electricity will always be more valuable and have a higher price than heat, independent of the question whether the electricity comes from renewable sources or not.

The **extended fractional energy savings** $f_{sav,ext}$ are defined in a similar way, but they also include electricity use for pumps, valves, controllers etc.

Finally, it is theoretically possible to achieve a high $f_{sav,therm}$ and $f_{sav,ext}$ and at the same time not meeting the comfort criteria for space heating or warm-water production. Therefore, the *fractional solar savings indicator* f_{si} is including a penalty term that compensates and even punishes for not meeting comfort criteria. For a complete discussion of these values refer to the design handbook of IEA SHC Task 26 [Weiss 2003].

6.2 Fractional savings for solar heating and cooling

For solar heating and cooling, the fractional solar thermal savings and extended solar thermal savings introduced in IEA SHC Task 26 are not applicable. Instead, *fractional solar heating & cooling savings* $f_{sav,shc}$ are defined:

The calculation of $f_{sav,shc}$ is similar to the calculation of the extended solar thermal savings of IEA SHC Task 26, with the following differences:

- The cooling energy load is introduced in the denominator, divided by the seasonal performance factor (of a standard heat pump) and the efficiency of electricity production and distribution.
- 2) The cooling energy not provided by the solar cooling system is not covered by an auxiliary cooling system in reality, but it must be accounted for in the fractional solar heating & cooling savings. This is done by introducing $Q_{cooling,missed}$.
- 3) Electricity consumption is not split up into parasitic electric energy and electric energy used for direct heating and/or cooling. Instead, all electricity consumptions of the solar heating and cooling system are included in W_{el} .

6.3 Penalty functions for DHW temperature

Penalty functions for not meeting the required tapping water temperature of 45 °C are calculated according to the IEA-SHC Task 26 handbook [Weiss 2003] and the IEA-SHC Task 26 minutes [IEA-SHC 2002b] as shown in Eq. 6.6 and Eq. 6.5.

6.4 Penalty functions for uncomfortable room temperatures

Penalty functions are calculated for not meeting comfort criteria as agreed upon in IEA-SHC Task 32 minutes. The lowest accepted room temperature is 19.5 °C always. The upper limit follows the recommended line of DIN 1946-2 (compare section 3.8).




Figure 6.1: room temperature limits for penalty functions for not meeting comfort criteria of IEA-SHC Task 32

The penalty function for not meeting room heating demand (room temperatures below 19.5 °C is calculated according to the IEA-SHC Task 26 handbook [Weiss 2003] as shown in Eq. 6.9 - Eq. 6.8). The penalty function for not meeting cooling demand (room temperatures above 24 °C) from the IEA SHC Task 26 handbook had to be adapted to match the one for room heating demand and to follow the maximum allowed room temperatures defined in DIN 1946-2 (see Eq. 6.9 - Eq. 6.10).

7 Interpretation of simulation results

In order to simulate your own system in the IEA-SHC Task 32 simulation environment, it is recommended to first set all parameters in the TRNEDIT environment accordingly, and then open the file *RefSol_XX.trd* in a text editor to insert your own TRNSYS Types and equations and connect them to the rest of the simulation system. If you are using the printer labeled "Task 32 monthly simulation results", please refer to the short list of the outputs in section 12.

7.1 General advices

- When simulating a system with a large store (seasonal storage), it is necessary to run a two year simulation and only use the values from the second year. Special attention has to paid that there is no significant difference in energy stored in the store at the beginning and at the end of the evaluation period.
- The standard TRNSYS-deck *RefSol_XX.trd* does not include a cooling device, and therefore the values for energy used for cooling will be zero. The user should insert his/her own cooling device and connect it to the building in order to calculate primary energy use of his/her cooling unit. The building is set up to calculate cooling demand (see section 12).
- Refer to section 7.3 for the choice of tolerance settings for convergence and integration errors and for the choice of simulation timestep.
- Check the energy balance of each loop and of the major Units. TRNSYS does not do this for you.
- Do not use your simulation results if penalties for dhw or space heating are above 5% of the energy demand of dhw or space heating respectively.

7.2 Reference systems (without solar)

Reference systems without solar collectors have been defined and simulated. The reference system calculations followed closely the descriptions in the Task 26 handbook [Weiss 2003] and can be summarized as follows:

- auxiliary energy measured on the water-side of the auxiliary boiler and divided by an efficiency factor of 0.85.
- store volume of 200 liters and a store loss of 644 kWh/a
- electric energy demand of space heating pump: 93 W
- electric energy demand of dhw pump: 55 W
- electric energy demand of burner: 35 W (on) and 9 W (standby)
- electric energy demand of controller: 1 W

Figure 7.1 - Figure 7.4 give an overview over the simulation results of the reference systems without solar heating or solar driven cooling for all buildings in all climates included in the reference conditions of this Task. The simulation timestep chosen for the simulation of the reference systems was 1/20 h.

The variables displayed are:

QSH space heating demand of an "ideal" heating system (convective and radiation energy from radiator)

QBURN demand of energy from burner to cover space heating, storage losses and DHW consumption

Qcool space cooling demand of an "ideal" cooling system

Qpen penalty for the system if no cooling is applied; since room temperatures below 19.5 °C do not occur in these reference systems and DHW demand is always met, the penalty is a result of not meeting cooling demand (room temperatures too high) only

WTOT total electricity consumption of the system




Figure 7.1: Simulation results for reference systems without solar collectors, city of Zurich, all reference buildings




Figure 7.2: Simulation results for reference systems without solar collectors, city of Stockholm, all reference buildings




Figure 7.3: Simulation results for reference systems without solar collectors, city of Madrid, all reference buildings




Figure 7.4: Simulation results for reference systems without solar collectors, city of Barcelona, all reference buildings




Figure 7.5: DHW-demand differences between the cities as a result of different cold water temperatures

The difference between QSH and QBURN equals storage losses of 664 kWh/a plus DHW-demand which is dependent on the city as shown in Figure 7.5. As a result, the energy that must be provided by the burner (QBURN) is 24.9 – 27 kWh/m²a higher than the energy needed for space heating alone (QSH) for all cities and all buildings.

7.3 Simulation results with solar systems




Figure 7.6: fractional thermal energy savings (left) and extended fractional energy savings (right) calculated with different simulation timesteps and different tolerance settings for convergence and integrated outputs. SFH60 Zurich, 20 m² selective flat plate collector, 1 m³ store volume. Calculated with version V45 of the reference deck.




Figure 7.7: fractional savings indicator (left) and time needed to run a simulation (right) calculated with different simulation timesteps and different tolerance settings for convergence and integrated outputs. SFH60 Zurich, 20 m² selective flat plate collector, 1 m³ store volume. Calculated with version V45 of the reference deck.

For the SFH 60 building and the location of Zurich, fractional energy savings and the time needed for the TRNSYS simulation are shown in Figure 7.6 and Figure 7.7. The different values obtained for different tolerances for convergence and integrated output (Tol) and different simulation timesteps lead to the following conclusions:

- consistent results are obtained for tolerance settings (convergence and integrated outputs) of 0.003 or lower and simulation timesteps of 2 minutes or 3 minutes
- especially the penalty-values (f_{si}) show a high uncertainty when the tolerance settings for convergence and integration are too high
- lowering the tolerance settings from 0.01 to 0.002 does not affect the time needed for calculations, whereas lowering the simulation timestep does.

Energy balances of the total system and/or of parts of the system showed errors that were larger than \pm 1% for tolerance settings \geq 0.006 (not shown in graphs).

Therefore, it is recommended to use a *convergence tolerance setting of 0.002 or 0.003*, and a *simulation timestep of 2 minutes or 3 minutes*. When different simulations are compared, care has to be taken not to compare results from simulations that were performed with different convergence tolerance settings and/or simulation timestep.

The general system settings used for these simulations are shown in Table 1. The simulations were performed on a FSC Amilo Pro V3205/T2250 mobile computer with 1.73 GHz and 504 MB RAM under Windows XP Professional, SP2.

8 Known problems

- With *convergence tolerance* set to *0.0001*, there are convergence problems in the auxiliary loop. Use higher values.
- According to the simulation results shown in section 7.3, it is recommended to set tolerances for convergence and integration error to 0.002 - 0.003, and run the simulations with timesteps of 2 or 3 minutes.
- Very large timesteps (e.g. > 10 minutes) should not be used at all, since in some cases values of previous timesteps are used for controller calculations.
- For *large stores*, the store-section heated by the auxiliary boiler for domestic hot
 water may be too large. This is due to the minimum number of nodes for the control of
 auxiliary heating of the *domestic hot water volume in the store*. If this could be a
 problem for your simulation studies, change the deck accordingly and report your
 changes thoroughly.
